Introduction and Parties

Introduction

This Event Participation Agreement (the "Agreement") is made and entered into as of August 9, 2025. This outlines the terms and conditions governing Acme, Inc.'s participation in the Acme Inc. Annual Tech Conference.

Parties

Organizer

DocuPal Demo, LLC, a company organized under the laws of the United States, with its principal place of business at 23 Main St, Anytown, CA 90210 ("DocuPal").

Participant

Acme, Inc ("ACME-1"), a business entity organized under the laws of the United States, with its principal place of business at 3751 Illinois Avenue, Wilsonville, Oregon - 97070, USA.

Event Details

This Agreement pertains to Acme Inc.'s participation in the Acme Inc. Annual Tech Conference, scheduled to take place from October 26-28, 2024. DocuPal Demo, LLC is the organizer of this event.

Participation Terms and Obligations

Participant Obligations

ACME-1 must ensure its participating employees or authorized representatives adhere to all rules and regulations set forth by DocuPal Demo, LLC for the Acme Inc. Annual Tech Conference. Participants are expected to conduct themselves



professionally and respectfully towards other attendees, staff, and event facilities. Any behavior deemed disruptive, offensive, or harmful will not be tolerated and may result in immediate expulsion from the event.

Organizer Responsibilities

DocuPal Demo, LLC will provide a safe and organized environment for all participants. This includes ensuring adequate facilities, staffing, and security measures are in place. DocuPal Demo, LLC is responsible for the overall management and execution of the Acme Inc. Annual Tech Conference, adhering to the agreed-upon schedule and program.

Code of Conduct

All participants are required to comply with the event's code of conduct, which emphasizes respectful communication, collaboration, and ethical behavior. ACME-1 is responsible for informing its representatives about this code.

Participation Requirements

Only employees or authorized representatives of ACME-1 are eligible to participate in the Acme Inc. Annual Tech Conference. ACME-1 must provide accurate and up-to-date information for all its participants.

Payment and Fees

Participation Fee

ACME-1 will pay DocuPal Demo, LLC a participation fee of \$5,000. This fee covers ACME-1's participation in the Acme Inc. Annual Tech Conference.

Payment Schedule

The full participation fee of \$5,000 is due on or before September 26, 2024.



Cancellation and Refunds

If ACME-1 cancels its participation before September 12, 2024, DocuPal Demo, LLC will refund 50% of the participation fee. There will be no refunds for cancellations made on or after September 12, 2024.

Late Payment Penalty

Late payments will incur a penalty fee of 5% of the outstanding balance. This penalty will be applied to any payments not received by September 26, 2024.

Liability and Indemnification

Limitation of Liability

DocuPal Demo, LLC will not be liable for any indirect, incidental, special, consequential, or punitive damages arising out of or relating to ACME-1's participation in the Acme Inc. Annual Tech Conference. ACME-1 acknowledges and agrees that DocuPal Demo, LLC's total liability for any and all claims arising out of or relating to this Agreement shall not exceed the total amount of fees paid by ACME-1 to DocuPal Demo, LLC under this Agreement.

Participant's Responsibility

ACME-1 is solely responsible for the actions and omissions of its employees, agents, or representatives during the Acme Inc. Annual Tech Conference. ACME-1 acknowledges that participation in the Conference carries certain inherent risks, including but not limited to the risk of personal injury or property damage. ACME-1 assumes all such risks.

Indemnification

ACME-1 agrees to indemnify, defend, and hold harmless DocuPal Demo, LLC, its officers, directors, employees, agents, and affiliates from and against any and all claims, losses, damages, liabilities, costs, and expenses (including reasonable attorneys' fees) arising out of or relating to ACME-1's participation in the Acme Inc. Annual Tech Conference, including but not limited to any claims arising from



ACME-1's breach of this Agreement, negligence, or willful misconduct. This indemnification obligation shall survive the termination or expiration of this Agreement.

Cancellation and Termination

Cancellation

Either party may cancel this Agreement with thirty (30) days' written notice. DocuPal Demo, LLC reserves the right to cancel the event due to unforeseen circumstances. ACME-1's cancellation is subject to the refund policy outlined in this Agreement.

Termination

This Agreement will terminate upon the conclusion of the event. Either party can terminate this Agreement with a written notice of 30 days. Upon termination, all rights and obligations of both parties will cease, except for those related to confidentiality and indemnification, which will survive termination.

Confidentiality and Intellectual Property

Confidentiality

Both DocuPal Demo, LLC, and ACME-1 agree to keep proprietary information shared during the Acme Inc. Annual Tech Conference confidential. This obligation survives the termination of this Agreement.

Intellectual Property

ACME-1 retains ownership of all intellectual property rights related to its products, services, and presentations at the event. DocuPal Demo, LLC retains ownership of all intellectual property rights related to the event itself, including but not limited to event materials, branding, and marketing content.



Data Protection

DocuPal Demo, LLC will comply with all applicable data privacy laws and regulations regarding the collection, processing, and storage of personal data of ACME-1's representatives and attendees.

Dispute Resolution and Governing Law

Dispute Resolution

DocuPal Demo, LLC and ACME-1 agree to first attempt to resolve any disputes arising from this Agreement through good faith negotiation. If negotiation fails, the parties will attempt to resolve the dispute through mediation before resorting to litigation.

Governing Law

This Agreement will be governed by and construed in accordance with the laws of the State of Delaware, without regard to its conflict of laws principles.

Miscellaneous Provisions

Amendments

This Agreement may be amended only by a written instrument signed by both DocuPal Demo, LLC and ACME-1.

Assignment

Neither party may assign its rights or obligations under this Agreement without the prior written consent of the other party. Any attempted assignment without such consent shall be void.



Entire Agreement

This Agreement constitutes the entire agreement between DocuPal Demo, LLC and ACME-1 relating to the subject matter herein. It supersedes all prior or contemporaneous communications and proposals, whether electronic, oral, or written, between the parties with respect to the Event.

Force Majeure

DocuPal Demo, LLC shall not be liable for any delay or failure to perform its obligations under this Agreement if such delay or failure is due to unforeseen circumstances or causes beyond its reasonable control, including, without limitation, acts of God, war, terrorism, riots, fire, natural disasters, or governmental regulations.

Signature and Execution

This Event Participation Agreement becomes effective as of the date of the last signature below. By signing this agreement, both DocuPal Demo, LLC and ACME-1 agree to all the terms and conditions outlined within this document.
