# Purpose and Objectives

This Memorandum of Understanding (MoU) formalizes a partnership between DocuPal Demo, LLC, and Acme, Inc. It establishes a framework for collaboration. This collaboration focuses on integrating DocuPal's document automation solutions within Acme, Inc.'s existing infrastructure.

## Primary Goals

The overarching goal is to improve document processing for ACME-1 by making it more efficient and accurate. DocuPal Demo, LLC, seeks to broaden the adoption of its document automation platform through this integration. ACME-1 intends to streamline its operations and decrease administrative expenses.

## Specific Objectives

- To successfully integrate DocuPal's technology with ACME-1 systems.
- To enhance the speed and accuracy of document-related workflows at ACME-1.
- To create a scalable model for future document automation initiatives.
- To foster a strong, collaborative relationship between DocuPal and ACME-1.

# Scope of Collaboration

This Memorandum of Understanding (MoU) outlines the scope of collaboration between DocuPal Demo, LLC, and Acme, Inc. (ACME-1) regarding the integration of DocuPal's document automation solutions with ACME-1's existing systems. The collaboration encompasses the integration of DocuPal's API to automate document creation and workflows within ACME-1's operations.

## Specific Areas of Cooperation

The primary areas of cooperation include:

### Acme, Inc

ACME-1 will provide DocuPal Demo, LLC with the necessary access to their existing systems for seamless integration. ACME-1 is responsible for actively providing user feedback to optimize the document automation solutions. ACME-1 will support internal training initiatives to facilitate user adoption within their organization.

### Accountability

To ensure accountability and alignment with the objectives of this MoU, both parties will participate in regular progress meetings. Quarterly performance reviews will be conducted to assess progress, address any challenges, and ensure the partnership remains on track.



# Duration and Termination

## Effective Date and Term

This Memorandum of Understanding shall become effective on January 1, 2024. It will remain in effect until December 31, 2025, unless terminated earlier as provided in this section.

## Termination

Either DocuPal Demo, LLC, or ACME-1 may terminate this MoU prior to its expiration date. Termination requires a written notice delivered to the other party at least 30 days in advance of the intended termination date.

# Confidentiality

## Scope of Confidential Information

Both Docupal Demo, LLC, and ACME-1 agree that all non-public information shared between them is confidential. This includes, but is not limited to, proprietary software code, customer data, business strategies, and financial information. Each party will protect the other's confidential information with the same degree of care they use to protect their own confidential information, but no less than reasonable care.

## Data Protection

Docupal Demo, LLC, and ACME-1 are committed to complying with all applicable data protection laws and regulations. This includes GDPR and CCPA. Both parties will implement appropriate technical and organizational measures. These measures ensure the security and confidentiality of personal data.

## Permitted Use and Disclosure

Confidential Information will be used solely for the purpose of this MoU. Disclosure to employees, agents, or consultants is permitted. However, they must have a need to know and be bound by confidentiality obligations no less restrictive than those



contained herein. Each party is responsible for any breach of this section by their employees, agents, or consultants.

## Term

The obligations regarding confidentiality outlined in this section will continue even after the termination of this MoU.

# Financial Arrangements

This Memorandum of Understanding (MoU) establishes a framework for collaboration. It is understood that this MoU does not create any direct financial obligations for either Docupal Demo, LLC, or ACME-1.

## Cost Allocation

Each party will be responsible for covering its own costs. These costs include implementation, training, and any other expenses incurred during the collaborative activities outlined in this MoU. There will be no reimbursement between Docupal Demo, LLC, and ACME-1 for these expenses.

# Intellectual Property Rights

## Existing Intellectual Property

DocuPal Demo, LLC and Acme, Inc. (individually, a "Party," and collectively, the "Parties") agree that each Party retains all right, title, and interest in and to its existing intellectual property. This includes, but is not limited to, patents, trademarks, copyrights, trade secrets, and know-how, that it owns or controls prior to the effective date of this Memorandum of Understanding (MoU). Each Party grants to the other a non-exclusive, non-transferable license to use its existing intellectual property solely for the purposes of performing its obligations and exercising its rights under this MoU.





## Intellectual Property Resulting from Collaboration

Any new intellectual property developed as a direct result of the collaboration between DocuPal Demo, LLC and Acme, Inc. will be jointly owned by both Parties. The Parties will discuss and agree upon the terms of ownership, protection, and commercialization of such jointly owned intellectual property in a separate written agreement. This agreement will address issues such as the allocation of costs for obtaining and maintaining intellectual property protection, the division of revenues generated from commercialization, and the rights and responsibilities of each Party with respect to enforcement of intellectual property rights.

## Amendments and Modifications

This Memorandum of Understanding may be amended or modified at any time by mutual written agreement of DocuPal Demo, LLC, and Acme Inc.

### Amendment Process

Any proposed changes to this MoU must be formalized in writing. These proposed amendments will then be reviewed by both parties. No amendment shall be effective unless and until it is signed by authorized representatives of both DocuPal Demo, LLC, and Acme Inc.

### Authorization

All modifications to this MoU require authorization. Specifically, the Chief Executive Officer (CEO) of DocuPal Demo, LLC, and the Chief Information Officer (CIO) of Acme Inc. must authorize any changes. This ensures that all amendments align with the strategic objectives of both organizations. All modifications will be properly documented and attached as an addendum to this MoU.

## Dispute Resolution

DocuPal Demo, LLC, and ACME-1 commit to resolving any disputes arising from this MoU through good faith negotiation. Both parties will make every reasonable effort to address concerns and reach a mutually agreeable solution.



## Mediation

If negotiation proves unsuccessful, both parties agree to participate in non-binding mediation. The parties will jointly select a qualified mediator. The mediation will be held in Anytown, CA, unless both parties agree to an alternate location. Each party will bear its own costs associated with the mediation, and the parties will share equally the fees and expenses of the mediator.

## Governing Law and Jurisdiction

This Memorandum of Understanding will be governed by and interpreted in accordance with the laws of the State of Delaware, United States.

### Jurisdiction

Any legal action or proceeding arising out of or relating to this MoU shall be brought exclusively in the state and federal courts located in Delaware. Both Docupal Demo, LLC, and Acme, Inc. consent to the jurisdiction of such courts for the purpose of any such action or proceeding.

## Communication and Reporting

Effective communication ensures the success of this collaboration. DocuPal Demo, LLC, and ACME-1 will maintain open lines of communication through several channels. Progress updates will be shared via bi-weekly conference calls. Parties will also provide updates through email.

### Reporting Schedule

ACME-1 and DocuPal Demo, LLC, will adhere to a quarterly reporting schedule. Each party will submit a comprehensive report within 30 days following the conclusion of each quarter. These reports will detail progress, challenges, and key performance indicators.





# Use of Logos and Branding

## Logo Usage

Each party may use the other party's logos and trademarks only with prior written approval. All usage must adhere strictly to the branding guidelines provided by the respective party.

## Branding Guidelines

ACME-1 and DocuPal Demo, LLC, will furnish their branding guidelines separately. Both parties agree to comply with these guidelines in all joint marketing materials, public announcements, and any other form of communication where the other party's logo or branding is displayed. Any deviation from these guidelines requires explicit written consent from the brand owner.

# Compliance with Laws and Regulations

DocuPal Demo, LLC, and ACME-1 will each ensure that their activities under this MoU comply with all relevant laws and regulations. These include, but are not limited to, data protection laws, anti-corruption laws, and export control regulations.

## Data Protection Compliance

Both parties recognize the importance of data privacy and security. We will comply with all applicable data protection regulations. This includes implementing appropriate technical and organizational measures to protect personal data.

## Industry-Specific Regulations

This collaboration is subject to industry-specific regulations concerning document security and data privacy. Both DocuPal Demo, LLC, and ACME-1 are committed to adhering to these regulations.



# Force Majeure

## Definition

Neither DocuPal Demo, LLC, nor ACME-1 will be liable for delays or failures in performance resulting from events beyond their reasonable control. These events include, but are not limited to, natural disasters, acts of war or terrorism, government regulations or orders, widespread system failures, and other similar unforeseen circumstances.

## Impact and Mitigation

If a force majeure event occurs, the affected party must promptly notify the other party. Performance under this MoU will be suspended to the extent necessitated by the force majeure event. Both DocuPal Demo, LLC, and ACME-1 will make reasonable efforts to mitigate the impact of any force majeure event and resume performance as soon as reasonably practicable.

## Signatories

This Memorandum of Understanding is executed as of January 1, 2024, by the duly authorized representatives of each party.

DocuPal Demo, LLC is represented by John Smith, CEO, who is authorized to bind the company to the terms of this MoU.

### Acme, Inc

Acme, Inc is represented by Jane Doe, CIO, who is authorized to bind the company to the terms of this MoU.



# Definitions and Interpretations

DocuPal Demo, LLC, a United States company located at 23 Main St, Anytown, CA 90210, and Acme, Inc, a United States business with address at 3751 Illinois Avenue, Wilsonville, Oregon - 97070, USA, are entering into this Memorandum of Understanding (MoU) to establish a framework for a collaborative partnership. Acme, Inc. has a track record of pursuing innovative solutions to improve how it operates. This shared focus makes this collaboration a good fit for both parties.

## Absence of Prior Agreements

Currently, there are no existing agreements that directly influence this MoU. This document stands alone as the foundation for the intended collaboration between DocuPal Demo, LLC, and Acme, Inc.



# Monitoring and Evaluation
