Introduction and Purpose

This Burial Agreement establishes the terms and conditions between DocuPal Demo, LLC, located at 23 Main St, Anytown, CA 90210, USA, and Acme Inc, located at 3751 Illinois Avenue, Wilsonville, Oregon – 97070, USA, regarding burial services. DocuPal Demo, LLC, hereafter referred to as "Provider," offers burial plots and related services. Acme Inc, hereafter referred to as "Client," wishes to procure these services for the burial of a deceased individual.

Purpose of this Agreement

This agreement clearly defines the rights and responsibilities of both parties. It ensures a mutual understanding concerning plot assignment, the scope of services included (such as grave digging and maintenance), payment schedules, and cancellation policies. By outlining these key aspects, this agreement serves to protect both the Provider and the Client. This document also aims to minimize potential disputes and ensure a respectful and dignified burial process.

Scope of Services and Burial Rights

This section defines the services Docupal Demo, LLC will provide to Acme, Inc (ACME-1) under this Burial Agreement, as well as the burial rights granted.

Burial Plot Assignment

Docupal Demo, LLC assigns to ACME-1 the exclusive right to use burial plot A-12. This assignment grants ACME-1 the right to inter remains in the designated plot, subject to the restrictions outlined in this agreement.

Included Services

The following services are included as part of this Burial Agreement:

• **Plot Provision:** The designated burial plot A-12 will be prepared and made available for interment.









- **Grave Digging:** Docupal Demo, LLC will provide the service of opening and closing the grave for each interment.
- **Grounds Maintenance:** Docupal Demo, LLC will maintain the grounds, including regular lawn care and upkeep of common areas.

Restrictions

ACME-1 agrees to adhere to the following restrictions regarding the use of the burial plot:

- No permanent structures may be erected on the plot.
- Only floral tributes are permitted.

Additional Services

ACME-1 has the option to purchase additional services from Docupal Demo, LLC, including:

- Headstone Installation
- Memorial Services

Details regarding the costs and scheduling of these additional services are available upon request and will be governed by a separate agreement.

Fees, Payments, and Financial Terms

ACME-1 agrees to the following fees and payment terms for the burial services provided by Docupal Demo, LLC. All amounts are in United States Dollars (USD).

Payment Schedule

A payment of \$5,000 is due upon the signing of this Burial Agreement. This initial payment secures the plot assignment and initiates the services outlined in this agreement.

Acceptable Payment Methods

Docupal Demo, LLC accepts payments via check, credit card, or bank transfer. Details for each payment method will be provided on the invoice.








Cancellation and Refunds

ACME-1 may cancel this agreement within 30 days of signing. Cancellations are subject to a \$500 cancellation fee. Refunds, less the cancellation fee, will be processed within 30 days of written cancellation notice. No refunds will be issued after 30 days from the signing date.

Cost Breakdown

The initial payment covers several aspects of the burial service. This includes the plot itself, essential services such as grave digging, and initial maintenance. The approximate distribution of costs is illustrated below:



Maintenance and Care Responsibilities

DocuPal Demo, LLC is responsible for the ongoing maintenance and care of the grounds. We will maintain the grounds in a neat and orderly condition.

Standard Maintenance

Our standard maintenance includes:









- Lawn care (mowing, trimming).
- General groundskeeping.
- Upkeep of pathways and common areas.

Additional Care Services

We offer additional care services for an extra fee. These services include:

- **Floral Services:** Placement of fresh floral arrangements on a recurring basis (weekly, monthly, etc.). Specific pricing depends on the arrangement type and frequency.
- **Grave Tending:** This includes weeding, cleaning of the headstone, and seasonal decorations. Pricing varies depending on the scope of services requested.

Legal Terms and Conditions

Termination

This agreement may be terminated under the following conditions:

- Non-payment of agreed fees by ACME-1.
- Violation of any terms outlined in this agreement by either party.

Docupal Demo, LLC retains the right to terminate this agreement if ACME-1 fails to meet its financial obligations. ACME-1 also retains the right to terminate this agreement if Docupal Demo, LLC violates the terms.







Limitation of Liability

Docupal Demo, LLC's liability is limited to the value of services provided under this agreement. Docupal Demo, LLC is not liable for indirect, incidental, or consequential damages.

Governing Law

This agreement shall be governed by the laws of the State of California, United States, where Docupal Demo, LLC is located.

Data Protection

Each party ensures that it complies with relevant data protection laws and regulations concerning the processing of personal data related to this Agreement.

Data Privacy and Confidentiality

DocuPal Demo, LLC and ACME-1 are committed to protecting your privacy. This section explains how we handle your personal data.

Data Collection and Purpose

We collect your name, address, and contact information. This data is used solely for identification. It allows us to manage your burial agreement effectively.

Data Protection and Security

Your data's security is our priority. We store your information using encrypted methods. Access to your data is strictly limited to authorized personnel. These measures protect your data from unauthorized access.

Data Sharing

We do not share your personal information with third parties. We will only disclose your information if we have your explicit consent or if required by law.

Payment and Late Fees

Payments must be made according to the agreed-upon schedule. Late payments incur a penalty. The late fee is 10% per month on the outstanding balance. We accept various payment methods, as detailed in the agreement.

Dispute Resolution

Any disputes arising from this Burial Agreement will be resolved through binding arbitration. This means a neutral third party will mediate the disagreement, and their decision will be final and legally binding.

Additional Services

We offer options for additional services such as headstone installation and memorial services. Costs for these services are available upon request and scheduling must be arranged in advance. Please contact us for a complete list and pricing.

Additional Services and Options

ACME-1 may request additional services beyond those included in the standard burial agreement. These services are scheduled upon request. We require a 48-hour notice for scheduling.







Headstone Installation

We offer headstone installation services. Pricing varies based on the size, material, and design of the headstone. A separate service agreement will detail specific costs.

Memorial Services

ACME-1 can arrange personalized memorial services. These services can include:

- Custom eulogies
- Musical performances
- Religious or non-religious ceremonies
- Floral arrangements

The cost of memorial services depends on the specific arrangements requested. A detailed estimate will be provided before scheduling.
