## **Introduction to Cremation Agreement**

This Cremation Agreement, effective August 9, 2025, outlines the terms and conditions under which Docupal Demo, LLC, located at 23 Main St, Anytown, CA 90210, United States, agrees to provide cremation services to Acme, Inc (ACME-1), located at 3751 Illinois Avenue, Wilsonville, Oregon - 97070, USA.

### **Purpose of Agreement**

agreement details the complete cremation process. This transportation of the deceased, the cremation procedure itself, and available choices for urns and memorial services. The primary aim is to clearly define the responsibilities, obligations, and rights of both Docupal Demo, LLC and Acme, Inc.

## **Scope of Services**

The scope of this agreement covers cremation services selected by Acme, Inc. This encompasses the following:

- Transportation of the deceased to the cremation facility.
- The cremation process, adhering to all legal and ethical standards.
- Options for urns and other memorial products.
- Additional services as mutually agreed upon and specified herein.

This agreement is intended to ensure a clear understanding between both parties regarding the cremation services to be provided. It also covers legal aspects, payment schedules, and possible modifications or termination of the agreement.

## **Definitions and Interpretations**

For purposes of this Cremation Agreement, certain terms have specific meanings. These definitions clarify the agreement and ensure a common understanding between Docupal Demo, LLC and ACME-1.

#### **Key Definitions**

- **Cremation:** The process of reducing human remains to bone fragments through intense heat. This process will take place at a licensed cremation facility.
- Authorized Representative: The individual legally authorized to make decisions regarding the cremation and disposition of the deceased. This person is designated by ACME-1.
- **Disposition:** The final placement of the cremated remains. This includes, but is not limited to, interment in a columbarium, scattering at a designated location, or retention by the Authorized Representative.
- **Agreement:** Refers to this Cremation Agreement, including any schedules, exhibits, or amendments.
- **Docupal Demo, LLC:** Refers to Docupal Demo, LLC, a company based in the United States, located at 23 Main St, Anytown, CA 90210.
- **ACME-1:** Refers to Acme, Inc, a business entity based in the United States, located at 3751 Illinois Avenue, Wilsonville, Oregon 97070, USA.
- **Services:** Encompasses all the services provided by Docupal Demo, LLC, as detailed in this agreement, including but not limited to transportation, cremation, and urn selection.
- Parties: Collectively refers to Docupal Demo, LLC and ACME-1.

These definitions will be used throughout the agreement to avoid ambiguity and ensure clear understanding of the terms and conditions outlined herein.

## **Services Provided**

DocuPal Demo, LLC will provide cremation services for Acme, Inc. These services include transportation of the deceased, the cremation process itself, and a temporary container for the cremated remains.

#### Cremation Process

We will perform the cremation in accordance with all applicable laws and regulations. DocuPal Demo, LLC is responsible for ensuring that the cremation is carried out respectfully and professionally.

#### **Transportation**

Transportation of the deceased to our facility is included. Options for specialized transportation services are available upon request.

#### **Urns**

A temporary container is provided for the cremated remains. Acme, Inc can select an urn from our available options. The cost of the urn is separate from the cremation service.

#### **Memorial Services**

Acme, Inc can arrange memorial services through DocuPal Demo, LLC. These services can be customized to meet the specific needs. Details and pricing for memorial services are available upon request.

# Client Responsibilities and Representations

Acme, Inc. is responsible for providing Docupal Demo, LLC with the necessary authorization for cremation. This includes authorization for the cremation itself and for the final disposition of the cremated remains.

#### **Required Documents**

ACME-1 must supply a certified copy of the death certificate. ACME-1 will also provide any other legal documents required for the cremation to proceed lawfully.

#### **Accurate Information**

Acme, Inc. is accountable for the accuracy of all information provided to Docupal Demo, LLC. This includes details pertaining to the deceased, legal next of kin, and any instructions regarding the cremation process or final disposition. ACME-1 is responsible for securing all necessary authorizations from the legally authorized person.









## **Pricing and Payment Terms**

ACME-1 agrees to pay Docupal Demo, LLC for the cremation services as detailed below. Payment is due in full upon signing this Cremation Agreement. The total cost includes fees for the cremation process itself, the selected urn (if applicable), and any additional memorial services chosen.

#### Fee Structure

The following table outlines the costs associated with the cremation services:

# **Authorization for Cremation and** Disposition

ACME-1 hereby authorizes Docupal Demo, LLC to perform cremation services for the deceased. This authorization includes the right to transport the deceased to the cremation facility. It also covers the cremation process itself and the subsequent disposition of the cremated remains.

#### **Required Consents**

ACME-1 acknowledges that this authorization serves as legal consent for both the cremation and the final disposition of the remains. No cremation will occur without this signed authorization.

#### **Deceased Information**

To comply with legal requirements, ACME-1 confirms the following information about the deceased:

## **Cancellation and Refund Policy**

ACME-1 may cancel this Cremation Agreement before the cremation process starts. If ACME-1 cancels before the cremation, a refund will be issued. This refund is subject to a cancellation fee.

#### **Cancellation Fee**

The cancellation fee covers administrative costs and any expenses already incurred by Docupal Demo, LLC. The cancellation fee is \$250.

#### **Refund Eligibility and Timeline**

To be eligible for a refund, ACME-1 must notify Docupal Demo, LLC of its decision to cancel this agreement in writing. This notification must be received before the cremation process begins. Refunds will be processed within 30 business days of receiving the cancellation notice. Failure to provide accurate information or obtain necessary authorizations may result in penalties, including the forfeiture of any amounts paid.

# **Indemnification and Liability**

#### **Indemnification**

Acme, Inc. will protect, defend, and hold harmless Docupal Demo, LLC, its officers, employees, and agents from and against any and all claims, liabilities, damages, losses, costs, expenses, or fees (including attorney's fees) arising out of or relating to inaccurate or incomplete information provided by Acme, Inc. This indemnification obligation survives the termination of this Agreement.

#### **Limitation of Liability**

Docupal Demo, LLC is liable for damages or losses directly resulting from its own negligence. However, Docupal Demo, LLC's total liability under this Agreement is limited to the total cost of the cremation services provided to Acme, Inc. Docupal







Demo, LLC is not liable for any indirect, incidental, special, or consequential damages, even if advised of the possibility of such damages. This limitation applies to the fullest extent permitted by law.

## **Governing Law and Dispute Resolution**

This Cremation Agreement shall be governed by and construed in accordance with the laws of the state of [State].

#### **Dispute Resolution**

Any dispute arising from or relating to this Agreement will be resolved through binding arbitration. The arbitration will take place in [State], in accordance with the rules of the American Arbitration Association. The decision of the arbitrator shall be final and binding on both Docupal Demo, LLC and ACME-1. Each party shall bear its own costs associated with the arbitration, and the parties shall share equally the fees and expenses of the arbitrator. This clause does not prevent either party from seeking injunctive relief in a court of competent jurisdiction.

## Signatures and Execution

This Cremation Agreement becomes effective upon the signature of both parties.
