Introduction and Purpose

This Distance Learning Agreement establishes a framework for a collaborative educational partnership. DocuPal Demo, LLC will provide distance learning courses and related support services. ACME-1 will implement the program for its employees or members.

Objectives

This agreement defines the responsibilities of each party. It also ensures high-quality education. It details the courses offered, the expected learning outcomes, and project timelines. It also explains the methods used to maintain quality and provide student support.

Scope
