## **Introduction and Parties**

#### Introduction

This 3D Printing Services Agreement (the "Agreement") outlines the terms and conditions under which DocuPal Demo, LLC will provide 3D printing services to Acme, Inc. This Agreement aims to clearly define the scope of services, pricing, ownership of designs, confidentiality obligations, delivery schedules, acceptance criteria, warranties, liabilities, termination conditions, dispute resolution methods, force majeure clauses, governing law, indemnification responsibilities, modification procedures, and notice delivery methods. By entering into this Agreement, both parties acknowledge their rights and obligations concerning the 3D printing services provided.

#### **Parties**

#### DocuPal Demo, LLC

DocuPal Demo, LLC, a company organized under the laws of the United States, with its principal place of business at 23 Main St, Anytown, CA 90210 ("DocuPal"), is a provider of 3D printing services.

#### Acme, Inc

Acme, Inc, a business organized under the laws of the United States, with its principal place of business at 3751 Illinois Avenue, Wilsonville, Oregon - 97070, USA ("ACME-1"), is the recipient of the 3D printing services provided under this Agreement.

# **Scope of 3D Printing Services**

DocuPal Demo, LLC will provide ACME-1 with 3D printing services as described in this agreement. These services include prototyping, production of parts, and design assistance. The specific details of each project, including design specifications,

materials, quantities, and delivery schedules, will be outlined in individual project statements of work.

#### **Types of Services**

- Prototyping: DocuPal Demo, LLC will create prototype parts based on ACME-1's designs. This allows ACME-1 to test and refine designs before full production.
- **Production of Parts:** DocuPal Demo, LLC will produce final parts in specified quantities, meeting ACME-1's required specifications.
- **Design Assistance:** DocuPal Demo, LLC can provide design assistance to optimize parts for 3D printing. This includes advice on material selection and design modifications.

#### Limitations

The services provided are subject to the limitations of available 3D printing technology and materials. DocuPal Demo, LLC will inform ACME-1 of any such limitations that may affect a project. We will use reasonable efforts to accommodate ACME-1's requests within these limitations.

#### **Expected Outputs**

The expected outputs of the 3D printing services include:

- Dimensionally accurate parts according to provided specifications.
- Parts made from the materials selected by ACME-1 or as otherwise agreed upon.
- Parts that meet the agreed-upon quality standards.
- Timely delivery of parts as per the project schedule outlined in the statement of work.

DocuPal Demo, LLC will perform quality checks to ensure that the parts meet the agreed-upon specifications before delivery. ACME-1 will have the opportunity to inspect and accept the parts upon delivery.

# **Pricing and Payment Terms**

#### **Pricing Structure**

Docupal Demo, LLC will provide 3D printing services to ACME-1 based on a pricing structure that considers several factors. These include the type and amount of material used, the total printing time required, the complexity of the design being printed, and any post-processing requirements necessary to complete the job. Detailed pricing information, specific to each project, will be outlined in **Appendix A** of this agreement. Each project's cost will be calculated based on these factors to ensure fair and transparent pricing.

### **Invoicing and Payment Schedule**

Docupal Demo, LLC will invoice ACME-1 for services rendered. ACME-1 agrees to remit payment within thirty (30) days of the invoice date. All invoices will clearly state the services provided, the corresponding costs, and the due date for payment. ACME-1 should direct any invoice inquiries to the Docupal Demo, LLC accounts receivable department.

#### **Payment Methods**

Docupal Demo, LLC accepts payments via credit card, bank transfer, and company check. For credit card payments, ACME-1 will provide the necessary card details and authorization for charges. For bank transfers, Docupal Demo, LLC will supply the required banking information. Checks should be made payable to Docupal Demo, LLC and mailed to 23 Main St, Anytown, CA 90210.

### **Late Payment**

In the event that ACME-1 fails to make payment within thirty (30) days of the invoice date, Docupal Demo, LLC reserves the right to assess a late payment fee. The late payment fee will be calculated at a rate of one and a half percent (1.5%) per month on the outstanding balance, or the highest rate permitted by law, whichever is lower. Continued failure to remit payment may result in the suspension of services and further legal action to recover the outstanding debt.









# **Intellectual Property Rights**

### **Ownership of Designs**

ACME-1 retains all rights, title, and interest in and to the designs it provides to Docupal Demo, LLC for 3D printing services. This includes, but is not limited to, any intellectual property rights associated with the designs, such as patents, copyrights, trademarks, and trade secrets. Docupal Demo, LLC acknowledges that ACME-1's designs are proprietary and confidential.

### **Ownership of 3D Printed Products**

ACME-1 will own the final 3D printed products resulting from the services provided under this Agreement, provided that ACME-1 owns or has the right to use the designs. Docupal Demo, LLC makes no claim to ownership of the printed products. ACME-1 is responsible for ensuring that it has all necessary rights to the designs used for 3D printing.

#### License Grant

Docupal Demo, LLC grants to ACME-1 a non-exclusive license to use the 3D printed products for ACME-1's intended purpose. This license is limited to the use of the products as they are delivered and does not grant ACME-1 any rights to modify, reverse engineer, or create derivative works from the designs or the 3D printed products, except as otherwise agreed in writing.

### **Protection of Intellectual Property**

Docupal Demo, LLC will take all reasonable steps to protect ACME-1's intellectual property rights. This includes maintaining the confidentiality of ACME-1's designs and preventing unauthorized access to or use of the designs. Docupal Demo, LLC will also ensure that its employees and subcontractors are aware of and comply with these obligations.







#### **Infringement**

ACME-1 is responsible for ensuring that its designs do not infringe upon the intellectual property rights of any third party. ACME-1 will indemnify and hold Docupal Demo, LLC harmless from any claims, damages, or expenses arising out of any such infringement.

# Confidentiality and Non-Disclosure

#### **Definition of Confidential Information**

For the purposes of this Agreement, "Confidential Information" means any nonpublic, proprietary information disclosed by one party (the "Disclosing Party") to the other party (the "Receiving Party"), whether disclosed orally or disclosed in written, electronic, or other form, relating to the Disclosing Party's business, including, but not limited to, design specifications, business plans, customer data, and pricing information.

### **Obligations of Confidentiality**

The Receiving Party agrees to protect the Disclosing Party's Confidential Information with the same degree of care that it uses to protect its own confidential information of a similar nature, but in no event less than reasonable care. The Receiving Party shall limit access to the Disclosing Party's Confidential Information to its employees, contractors, and agents who have a need to know such information for the purpose of performing their obligations or exercising their rights under this Agreement and who are bound by confidentiality obligations no less protective than those contained herein.

#### **Permitted Disclosures**

The Receiving Party may disclose Confidential Information if required to do so by law, regulation, or court order, provided that the Receiving Party provides the Disclosing Party with prompt written notice of such requirement prior to disclosure, to the extent permitted by law, and reasonably cooperates with the Disclosing Party in opposing such disclosure or seeking a protective order or other appropriate relief.







#### **Exclusions**

Confidential Information shall not include information that: (a) is or becomes generally available to the public other than as a result of disclosure by the Receiving Party or its representatives; (b) was available to the Receiving Party on a nonconfidential basis prior to its disclosure by the Disclosing Party; (c) is independently developed by the Receiving Party without use of or reference to the Disclosing Party's Confidential Information; or (d) is rightfully received by the Receiving Party from a third party without restriction on disclosure.

# **Delivery and Acceptance**

### **Delivery Schedule**

Docupal Demo, LLC and ACME-1 will agree upon delivery deadlines for each individual project. These deadlines will be formally documented within the applicable project scope or purchase order. Docupal Demo, LLC will make every reasonable effort to meet the agreed-upon delivery dates.

#### **Delivery Methods**

The delivery of printed items will be carried out via shipping or local pickup, as agreed upon by both parties for each project. Shipping costs, if applicable, will be the responsibility of ACME-1, unless otherwise specified in the project agreement. Docupal Demo, LLC will ensure that all items are properly packaged to prevent damage during transit.

### **Acceptance Criteria**

Acceptance of the delivered items by ACME-1 is contingent upon meeting the following criteria:

- **Dimensional Accuracy:** The printed items must adhere to the dimensional specifications outlined in the approved design documents, within industrystandard tolerances.
- Material Quality: The materials used in the printing process must conform to the agreed-upon material specifications, free from defects that could compromise the item's functionality or integrity.







• Adherence to Design: The printed items must accurately reflect the design specifications, including surface finish, color, and any other relevant aesthetic or functional requirements.

#### **Inspection and Rejection**

Upon delivery, ACME-1 will inspect the printed items to ensure they meet the acceptance criteria. ACME-1 has the right to reject any items that fail to meet these criteria. Notification of rejection must be provided to Docupal Demo, LLC in writing within [insert number] business days of delivery. The written notification must detail the specific reasons for rejection. If items are rejected, Docupal Demo, LLC will, at its option, either repair or replace the rejected items within a reasonable timeframe, or provide a refund for the rejected items. The timeframe for repair or replacement will be mutually agreed upon.

#### **Acceptance Confirmation**

Final acceptance will be confirmed by ACME-1 through a written acceptance notice. This confirmation indicates that the delivered items meet all specified requirements and that ACME-1 is satisfied with the delivered products.

# **Warranties and Liability**

#### **Warranty Coverage**

DocuPal Demo, LLC warrants that all 3D printed items delivered to ACME-1 will conform to the specifications agreed upon in the applicable Statement of Work. This warranty remains in effect for a period of thirty (30) days from the date of delivery. Should any defects in materials or workmanship be discovered during this period, ACME-1 must notify DocuPal Demo, LLC in writing, detailing the nature of the defect.

DocuPal Demo, LLC's sole obligation under this warranty is, at its option, to either repair or replace the defective 3D printed items. This warranty does not apply to defects resulting from:

- Improper use or handling by ACME-1.
- Unauthorized modifications or repairs.
- Normal wear and tear.









• External causes such as accidents, abuse, or other actions beyond DocuPal Demo, LLC's control.

This warranty is exclusive and in lieu of all other warranties, whether express or implied, including any implied warranties of merchantability or fitness for a particular purpose.

#### **Limitation of Liability**

To the maximum extent permitted by applicable law, DocuPal Demo, LLC shall not be liable to ACME-1 for any indirect, incidental, consequential, special, or punitive damages arising out of or related to this Agreement or the 3D printing services provided, even if DocuPal Demo, LLC has been advised of the possibility of such damages. These excluded damages include, but are not limited to, loss of profits, loss of use, loss of data, and business interruption.

In no event shall DocuPal Demo, LLC's total liability to ACME-1 for any and all claims arising out of or related to this Agreement exceed the total amount paid by ACME-1 to DocuPal Demo, LLC for the specific 3D printing services that gave rise to the claim. This limitation of liability applies regardless of the form of action, whether in contract, tort, or any other legal theory. ACME-1 acknowledges and agrees that this limitation of liability is a material term of this Agreement and a reasonable allocation of risk.

## **Term and Termination**

This Agreement will begin on August 9, 2025, and continue for one year. After the initial year, this Agreement will automatically renew. This renewal will occur for successive one-year terms.

#### **Termination**

Either party can terminate this Agreement. To do so, written notice must be provided 30 days before the desired termination date.

### **Early Termination**

ACME-1 or Docupal Demo, LLC may terminate this Agreement early under the following circumstances:







- **Breach of Contract:** If either party fails to meet its obligations as defined in this Agreement.
- **Insolvency:** If either party becomes insolvent or enters into bankruptcy proceedings.
- Failure to Pay: If ACME-1 fails to pay Docupal Demo, LLC according to the
  agreed-upon payment schedule. In the event of early termination, any
  outstanding payments for services already rendered will become immediately
  due.

# **Dispute Resolution**

Docupal Demo, LLC and ACME-1 agree to resolve any disputes through good faith negotiation. Both parties will attempt to resolve disagreements quickly and efficiently.

#### **Negotiation**

If a dispute arises, both parties will first try to resolve it informally. This involves direct communication between representatives of Docupal Demo, LLC and ACME-1. Both parties will share all relevant information. The goal is to reach a mutually agreeable solution.

#### Mediation

If negotiation fails, both parties agree to attempt mediation. A neutral third party mediator will be selected. The mediator will help facilitate discussions. The mediator will not make a decision for the parties. Instead, the mediator assists in finding common ground. Both parties will share the costs of mediation equally. Mediation must occur before either party pursues legal action.

# **Force Majeure**

Neither DocuPal Demo, LLC nor ACME-1 will be liable for delays or failures in performance. This applies when such issues arise from circumstances beyond their reasonable control. These circumstances include, but aren't limited to, acts of God, war, government regulations, or labor strikes. Natural disasters also fall under this category.







#### **Notification of Force Majeure**

If a force majeure event occurs, the affected party must notify the other in writing. This notification must happen within 10 days of the event's occurrence. The notice should detail the event and its expected impact on performance.

# **Compliance with Laws**

Docupal Demo, LLC and ACME-1 will each comply with all applicable federal, state, and local laws, ordinances, regulations, and codes in connection with the performance of its obligations under this Agreement.

### **Monitoring Compliance**

Docupal Demo, LLC will monitor compliance through regular audits and quality control checks. These checks will ensure that the 3D printing services meet the required legal and regulatory standards.

#### **Governing Law**

This Agreement is governed by and construed in accordance with the laws of the State of Delaware, without regard to its conflict of laws principles. Both parties agree to adhere to these legal standards.

## Indemnification

#### **General Indemnity**

Acme, Inc. will indemnify and hold harmless DocuPal Demo, LLC, its officers, directors, employees, and agents from and against any and all claims, losses, damages, liabilities, costs, and expenses (including reasonable attorney's fees) arising out of or relating to the use of the 3D printed products. This indemnification includes, but is not limited to, claims for personal injury, property damage, or economic loss.





#### **Scope of Indemnity**

This indemnification obligation applies regardless of whether such claims are based on breach of contract, tort (including negligence), strict liability, or any other legal theory. However, Acme, Inc. is not required to indemnify DocuPal Demo, LLC for claims arising out of DocuPal Demo, LLC's gross negligence or willful misconduct. This means ACME-1 is responsible for any issues that arise from how the printed products are used.

#### Notice and Cooperation

In the event of any claim subject to indemnification under this Agreement, DocuPal Demo, LLC will promptly notify Acme, Inc. in writing. DocuPal Demo, LLC will reasonably cooperate with Acme, Inc. in the defense of any such claim. Acme, Inc. will have the sole right to control the defense and settlement of any claim, provided that Acme, Inc. will not settle any claim without DocuPal Demo, LLC's prior written consent, which will not be unreasonably withheld.

## Miscellaneous Provisions

#### **Entire Agreement**

This Agreement constitutes the entire agreement between Docupal Demo, LLC and ACME-1 relating to the 3D printing services described herein. It supersedes all prior or contemporaneous communications and proposals, whether electronic, oral, or written, between the parties with respect to the subject matter of this Agreement.

#### Amendments

No modification, amendment, or waiver of any provision of this Agreement will be effective unless it is in writing and signed by authorized representatives of both Docupal Demo, LLC and ACME-1.

#### **Notices**

All notices and other communications under this Agreement must be in writing. Notices will be considered duly given when delivered via email and certified mail to the addresses listed in this Agreement, or to such other address as either party may

designate in writing from time to time.

#### Severability

If any provision of this Agreement is held to be invalid or unenforceable, the remaining provisions of this Agreement will remain in full force and effect. The invalid or unenforceable provision will be replaced by a valid and enforceable provision that comes closest to expressing the intention of the original provision.

#### **Governing Law**

This Agreement shall be governed by and construed in accordance with the laws of the State of California, without regard to its conflict of laws principles.

#### Force Majeure

Neither party shall be liable for any failure to perform its obligations under this Agreement if such failure is caused by acts of God, war, terrorism, civil unrest, labor disputes, fire, flood, or other events beyond the reasonable control of such party. The affected party shall notify the other party promptly of such event and shall use commercially reasonable efforts to mitigate the impact of such event.

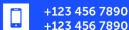
