Project Phases


- 1. **Discovery:** This initial phase involves gathering detailed requirements and understanding ACME-1's specific needs and goals for the e-commerce platform.

Docupal Demo, LLC will provide ecommerce website development services for ACME-1. The total cost for this project is \$75,000. This includes design, development, and integration.


