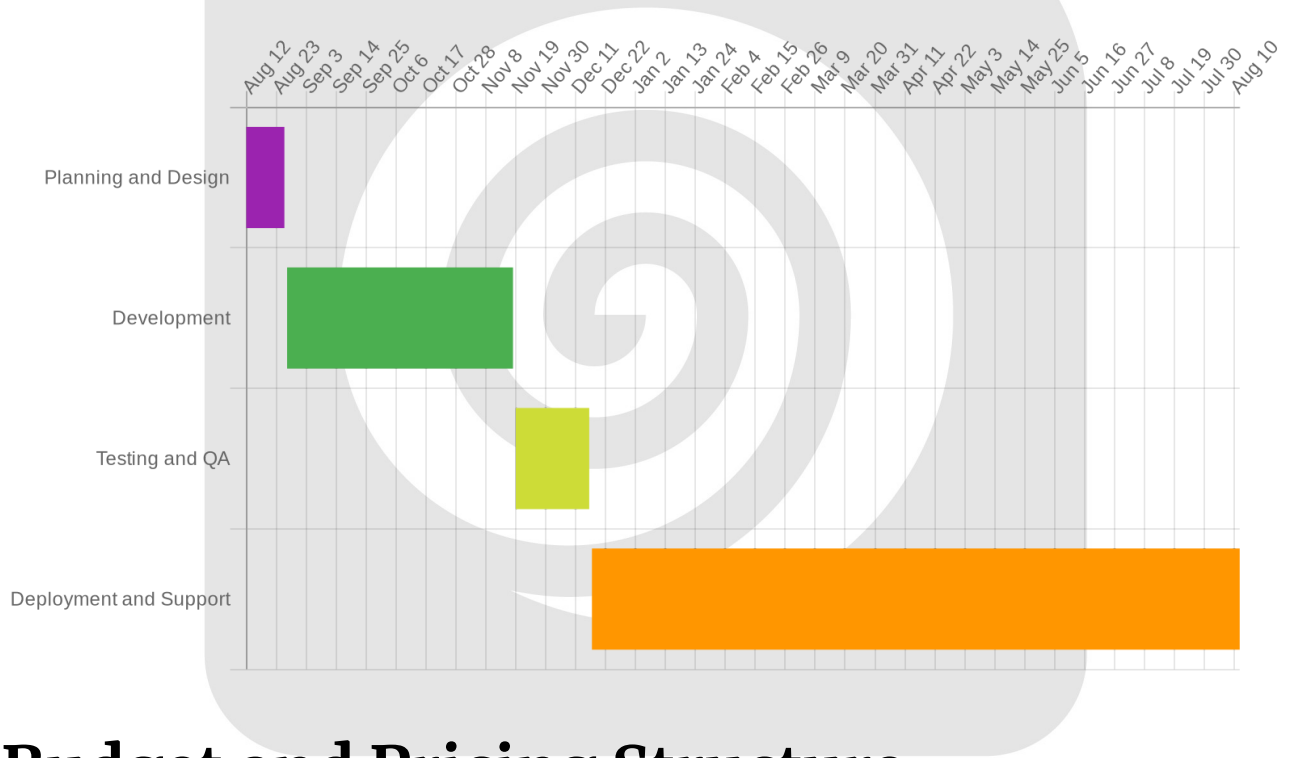

Budget and Pricing Structure

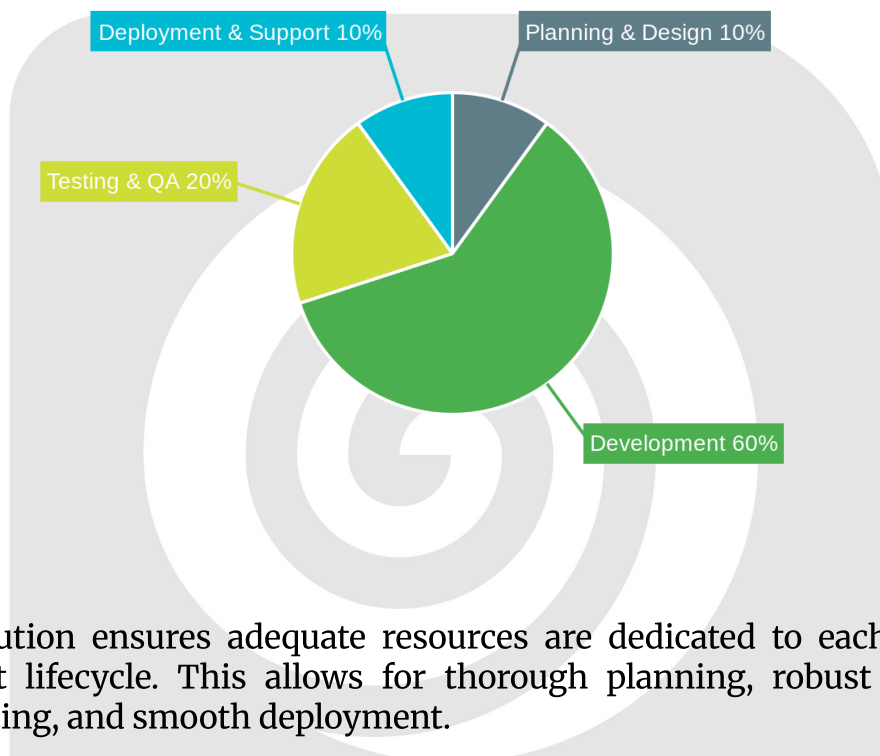
