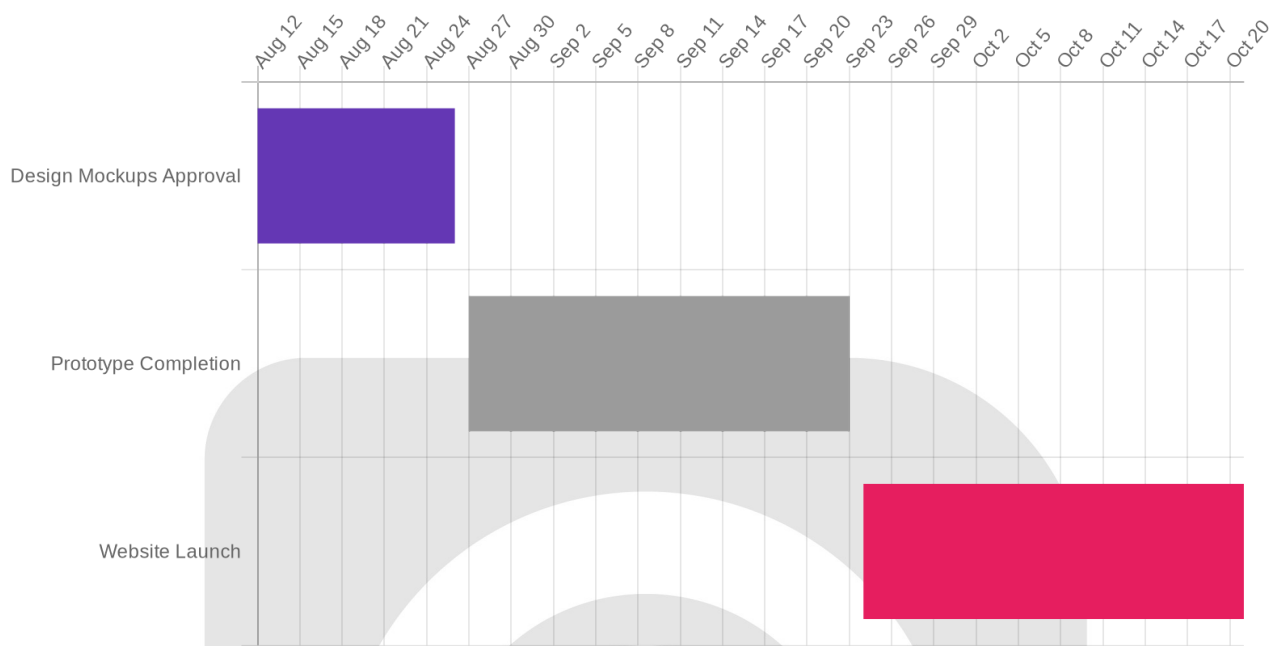

Budget and Pricing

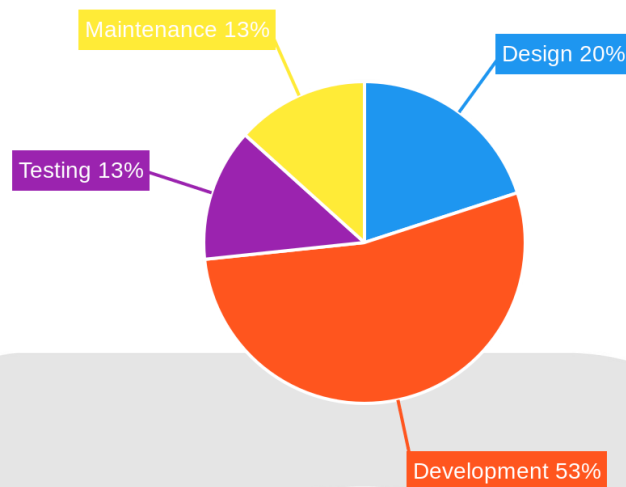
