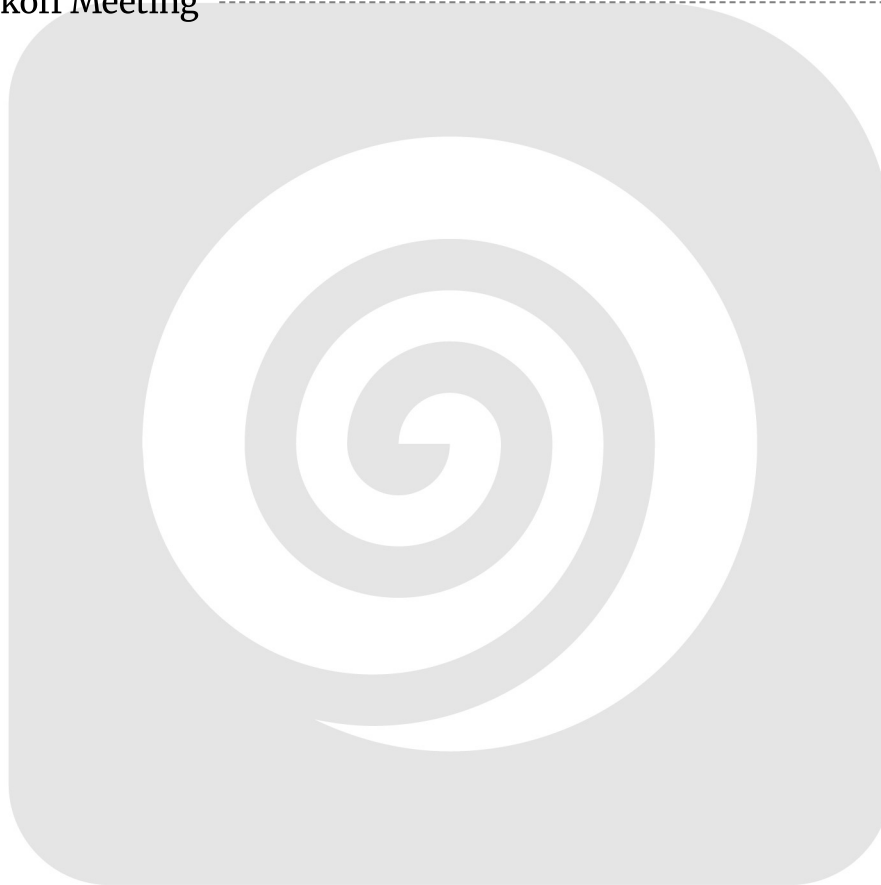

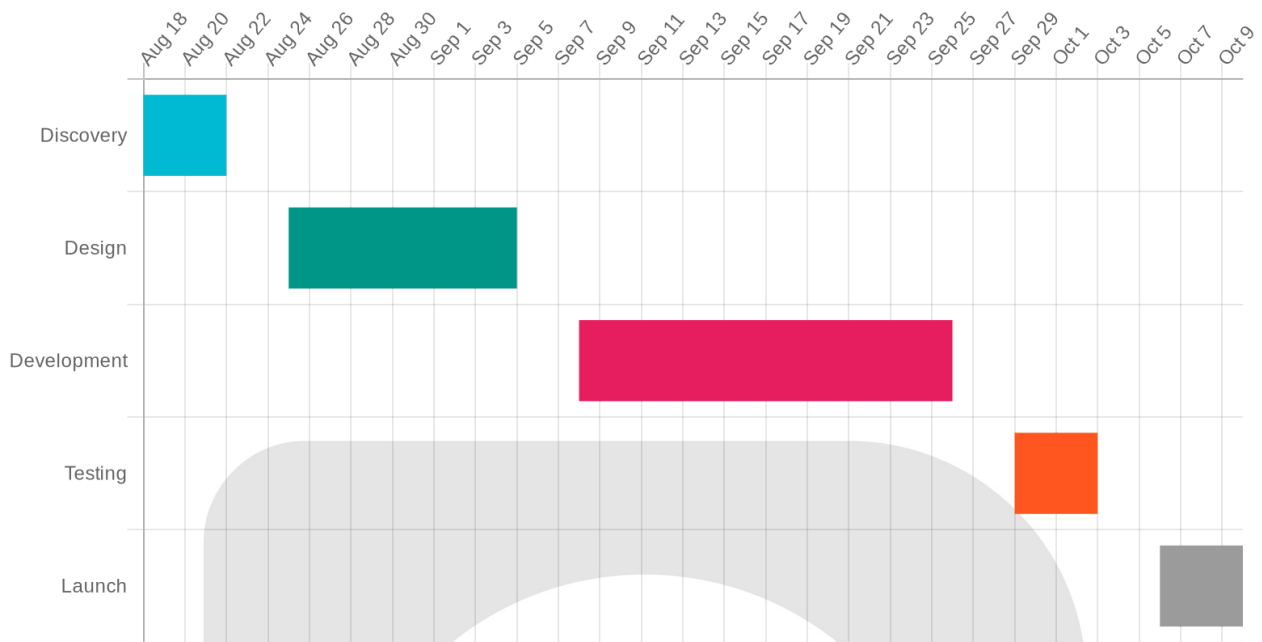

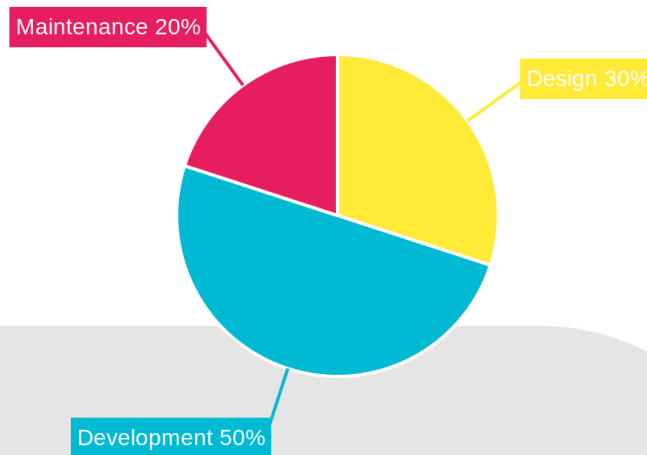
Budget and Pricing

Cost Breakdown
